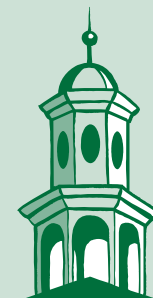

## ABOUT THE LEAGUE

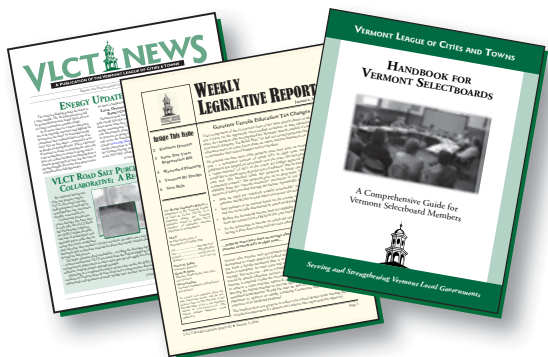
The Vermont League of Cities and Towns (VLCT) is a non-profit, non-partisan association founded in 1967 to serve the needs and interests of Vermont's municipalities.

VLCT's regular and associate membership, available to local government, has nearly 400 members including all 246 cities and towns; villages; housing authorities; fire, water, recreation, and solid waste districts; and county courts.

In all, VLCT assists more than 6,000 elected and appointed town officers, managers, and department heads by offering legislative advocacy, information sharing, educational programs, and risk management services. VLCT also works with state agencies, Vermont's congressional delegation, and the National League of Cities to advance municipal interests at the state and federal levels.

## CONTRIBUTING MEMBERSHIP

The VLCT Contributing Membership Program is open to businesses, individuals, and organizations that share the League's mission of serving and strengthening Vermont's local governments. The program gives full-time access to VLCT's resources and a range of opportunities to interact with public officials in settings where they are most open to learning and sharing ideas.

## DUES

Contributing members shall be assessed annual dues based on their annual gross revenue. The membership year runs from July 1 to June 30.
