#### How To Use This Manual

In this manual we will use the term selectboard for consistency's sake, but the information contained within is applicable to any legislative body. This manual is intended to focus your efforts navigating the wide range of MAC resources relevant to the selectboard's discharge of their duties. The information contained in the former publication, *The Selectboard Handbook*, has been updated and posted to the website as distinct resources organized by topic and are updated on an ongoing basis.


