Grants & Funding: Wastewater

- Does your community need a wastewater system and not know where to start?
- Do you have a system that needs specific upgrades, such as energy efficiency measures?

Wastewater projects are rarely funded by municipalities alone: they usually require the municipality to build a funding stack of grants, loans, and municipal funds. The more complicated the project, the more funding sources it will have.
