

**What evidence should the municipality request from a developer to demonstrate that a project can be privately financed?**



If the developer proposes private financing, it is common to require a commitment letter from a financial institution which demonstrates that the bank is familiar with the project and will provide financing if the CHIP plan is approved. This letter may be conditioned upon final loan approval and subject to typical loan documentation.
