

VIC Hosting Sports and Special Events Management Training Courses

(U) The Vermont Intelligence Center (VIC), in coordination with Federal Emergency Management Agency (FEMA), Texas A&M Engineering Extension Service (TEEX), and the University of Southern Mississippi's National Center for Spectator Sports Safety and Security (NCS⁴), will be hosting training for the TEEX Sports and Special Events Management program in Williston, VT. This training is being offered free of charge to our public and private sector Critical Infrastructure (CI) partners.

(U) Protecting against, responding to, and recovering from emergencies – from natural or human causes – during sports or other large-scale events requires specialized knowledge and training. These courses focus specifically on incident management, crowd and evacua-



tion management, crisis information management, and developing capability to operate in multi-agency collaborations. Training is targeted to personnel in campus administration/emergency management; athletic department management; campus, local and state law enforcement; local and state emergency management; local fire and emergency medical services; and large venue management/operations. Participants will collaborate on basic concepts for planning, risk assessment, training, exercises for plans, and recovery/business continuity.

Your FEMA SID uniquely identifies you throughout the FEMA organization and all of its agencies. It serves as your personal identification number and combines all of your FEMA training records under one account to simplify tracking of all your FEMA training accomplishments. - (U) Participants will need access to a laptop or mobile device/tablet during the class to complete electronic, web-based course testing and evaluations.
