This manual has been specifically developed for municipalities that have employees operating commercial motor vehicles (CMVs) - vehicles that have a gross vehicle weight rating of 10,001 pounds or more, such as dump trucks and garbage/recycling vehicles. This is an important resource to **help your municipality comply with federal drug and alcohol testing, hiring, and ongoing recordkeeping requirements.**

*If your municipality does **not** have CMVs that are driven by employees, you are not required to comply with federal CMV requirements and do not need this manual.*

PACIF Risk Management Services has developed this manual to help you comply with Federal Motor Carrier Safety Administration (FMCSA) and U.S. Department of Transportation (DOT) requirements. In it you will find numerous resources, forms, guidance, and a model drug and alcohol testing policy.
